Concession Conditions

Primary Producer/Farm Plate Concessions

Primary Producer means a person engaged mainly in the production of raw material for clothing or food, derived from agriculture or dairying or fishing or raising of livestock or viticulture.

Eligible vehicles are prime movers or trucks with a GVM of 6t or more and trailers with an ATM of more than 4.5t that are used for carrying on your business as a Primary Producer.

Co-operative Associations may only carry produce owned by a member of that co-operative. The vehicles can only be used for the carriage of that produce between the point of primary production and the first point of processing or other transport (e.g. rail head).

Farm Plates are issued for vehicles used only by Primary Producers in their business as a Primary Producer. These vehicles are restricted to travel between different parcels of land managed by the Primary Producer. The travelling distance is restricted to the maximum distance allowable as in the Conditional Registration Scheme Zone Access category.

These vehicles are excluded from built-up areas.
